III. ORDER TERMS AND CONDITIONS

- a. **Governing Agreement.** By executing this AWS Reseller Order Form ("Order") with Aligned Technology Group, Inc., a North Carolina corporation ("AlignedTG"), Customer acknowledges and accepts being bound to the terms and conditions herein. This Order is effective as of the Effective Date. This Order contains the entire understanding of the parties with respect to the subject matter hereof and supersedes all prior agreements and understandings, oral or written, with respect to such matters, which the parties acknowledge have been merged into this Order.
- b. **Payment Terms.** AlignedTG will issue monthly invoices to Customer in advance for the fees set out above. All invoices are due and payable by Customer within 30 days from the date of AlignedTG's invoice in US dollars. Past-due invoices shall bear interest at a rate of the lesser of 1.5% per month or the highest rate permitted by law and Customer shall reimburse AlignedTG for all reasonable costs incurred (including reasonable attorney fees) in collecting past due amounts owed by Customer.
- c. **Term.** Subject to Customer's fulfillment of its payment obligations hereunder, the Services will commence on the Effective Date and will continue until either party terminates this Order by written notice to the other party.
- d. **AWS Resell Services.** Subject to this Order, AlignedTG shall provide billing services as they relate to the Supported Services including bill analysis, bill correction, and strategic planning in regard to Supported Services spend used by Customer. Customer hereby grants AlignedTG the limited rights and authority required to perform these Services on its behalf to the necessary third-party providers. AlignedTG provides no additional services related to the performance or use of the Supported Services.
- e. **Supported Services.** The Supported Services identified above are provided by a third-party service provider. Customer acknowledges that its use of such Supported Services will be subject to its agreement and adherence to any and all required terms and conditions provided by such third-party. Customer hereby acknowledges that AlignedTG will have read-only access to the Customer's billing accounts related to such Supported Services. AlignedTG disclaims any and all warranties and liabilities associated with the performance of Supported Services.
